September 13, 2010 Budget General Meeting minutes – read in full by Liz Johnston

MOTION: To approve the minutes as amended: replacing the words within the Executive report section "regarding DICEEC" with "regarding the future of the Economic Enhancement Services" **M/S/Carried**

Guest Presentation: Shari Dunnet of Hornby Denman Community Health Care Society (HDCHCS) introduced her October 2010 Flagstone article "'Age-friendly Communities' Grant helps Denman & Hornby Plan for Our Future". Their strategy would result in a living statistical document on the islands' population dynamics. This information in turn would also be available to community groups such as business or recreation for their own needs. Gerald Hodge, a national community planner, will assist as a consultant. The planning would include surveys on 65+ seniors (e.g. November 10 flu shot clinic), input from focus groups and existing models and Flagstone communications. HDCHCS request a Letter of Endorsement in principle from DIRA.

ACTION: DIRA will provide HDCHCS with a Letter of Endorsement with regards to the use of the grant towards the "Age-friendly Communities" planning.

Executive Board Report:

1. DIRA had sent a letter to CVRD requesting firstly, that they attend a DIRA General Meeting to discuss and explain specific queries regarding the DICEEC budget and secondly, with DIRA's assistance, to adequately notify the Denman community, to facilitate and organize a meeting with the community to discuss tax and related services. Ian Smith of CVRD confirmed that they plan to comply but could not make the October general meeting.

- 2. Research regarding HST indicates that DIRA qualifies as Non-Profit Public Service Body, so can simply apply for HST rebates. Fortunately DIRA is not required to become an HST Registrant, as that would require not only charging HST on all DIRA services, but would also require a ongoing reporting. Application can simply be made for a rebate of HST, but is restricted to 50% of amounts paid out. Rebate forms are available for committees from the Chair, but the Executive still plans to meet with all Committee Chairs to discuss further.
- 3. Transferring to AXIS Insurance is still on-going but on track. Information has been provided by Liz Johnston and Gloria Michin to assist K. Britnall of AXIS in completing the new policy and have in place by the October 28, 2010 deadline.

MOTION: That the DIRA Executive request that CVRD provide the Economic Enhancement Reconciliation financial report, earlier requested, be available to DIRA and the public prior to CVRD attending the next DIRA General Meeting. **M/S/Carried**

Committee Reports:

Parks Committee: Both Peter Karsten and Laura Pope were absent. Henning Neilson read their Activity Report (Incoming Correspondence # 10) and answered questions with regards to the new North Denman Park donated to Ministry of Environment for BC Parks conservancy protection.

Waste Management Committee: Bob French reported that the glass crusher in now in operation and that the new storage bins are in place. The larger bin is used for scrap metal and the other for crushed glass. A letter of request was submitted to CVRD's Solid Waste and subsequently the crusher and bins were paid (approximately \$17,000 to \$18,000) in full from its budget and not from the capital reserve fund. They will remain the property of CVRD but Bob will investigate as to the insurance coverage.

Denman Island Community Economic Enhancement Committee (DICEEC):

There is no report but Simon Palmer advised that DIRA Executive will soon be notified of assembled volunteers committed to addressing the tax and budget questions and looking at ongoing endeavors.

Liaison Reports:

VIRL: Bill Engleson spoke of formal requests to Bruce Joliffe to provide a timeline on consideration on new Vancouver Island Regional Library Branches, but feedback has been minor. He will continue to address the continuing challenge dealing with the underfunded and undersized branch.

Islands Trust: David Graham presented the Islands Trust yellow handout distributed in a recent Grapevine issue titled "Official Community Plan Review/ Community Information Meeting/ Wed. Oct.20, 2010" where maps, displays and new OCP policies regarding conservation will be discussed.

New Business:

Pat Veness expressed extreme dissatisfaction with services provided and charged by Able & Ready pump out services. In addition to inadequate service and inaccurate information being provided, he incurred additional costs contracting back hoe services to rectify his situation.
