DIRA Dock Committee Tender Agreement

The Executive all agreed that further to the DIRA Treasurers approval on this matter, that Such a request from a resident committee at large was consistent with the DIRA mandate, to further and consider the welfare of Denman Residents. Nettie expressed concern that there should be no reporting responsibility aspect required by DIRA re these funds. All were in agreement on this criteria. The Chair will consult with Derek, and get back to Peter Karsten.

Re: Letter of request from Edi Johnston for a secret ballot for March Notice of motion Edi Johnston has made the request in writing for a secret ballot for the March notice of motion vote. She will be required to present this request as a motion prior to the vote.

If passed by the membership then the DIRA executive will be ready. As all residents and taxpayers can vote on this issue, there will be no need to go thought the membership list. If there is a secret ballot, then one executive member (who is not otherwise tasked) will Disperse and collect the votes, and two members will be picked to assist with counting.
